HRA Discount Report Moved to ARBenefits

Health Insurance Representatives will no longer be receiving weekly e-mails regarding the HRA discount for their employees. Instead, the information can be accessed at any time by clicking the **Reports** link located on the top menu of the ARBenefits.org site (Security Login Required). Once in the Reports section, click the link titled **HRA Survey Credit Report**. On this screen, enter a specific date from when you would like to see HRA information.

For Example, if you want to see all HRA changes since the beginning of May, you would enter 5/1/08 in the field titled **Discounts Changed On or After** and click the **Show Discounts** button. This list will show all discounts that have been added or changed since May 1, 2008.
